## CANCELLATIONS

All cancellations to be done in writing, NO verbal cancellations will be accepted. Any cancellation made ON or BEFORE 31 July 2026 will be subject to a 50% cancellation fee. Cancellations made AFTER 31 July 2026, will be subject to paying 100% of the full invoiced price.



## GENERAL INFORMATION

### CONSTRUCTION RULES

- No construction spanning/protruding into or over an aisle will be allowed
- No construction may be attached to the walls or ceilings
- No bolts, screws, glue, adhesives or any other fixings may be used on any structure in the venue
- Display material may be fixed to the stand shell scheme by using double sided tape, sticky back VELCRO (to be provided by you). Hooks may be used to suspend heavier objects
- Should any construction work take place at the stand, necessary precautions must be taken not to damage the venue walls or floors. Any damage caused will be for the expense of the exhibitor
- No high combustible materials may be used as part of the stand
- No solid ceilings may be set-up
- Draping must be treated with fire retardant spray and a valid certificate attesting to this must be given to the onsite Co-ordinator.

### PRIVATE STAND BUILDERS

Companies making use of private shell scheme builders can start building from:

#### Monday

26 October 2026 between 07h00-21h00.

#### Tuesday

27 October 2026 between 07h00-14h00.

### SET-UP (DRESS THE STANDS)

Exhibitors will have access to the Conference venue to build private stands or to DRESS stands from:

#### Monday

26 October 2026 between 12h00-21h00.

#### Tuesday

27 October 2026 between 08h00-14h00.

All stands must be fully dressed by 14h00 on Tuesday, 27 October 2026. NO exhibitors will be permitted to dress their stands after this time without prior permission from IMESA.

### ELECTRICITY

An exhibitor providing their own electrical installations must hand in an electrical certificate of compliance (CoC) to the onsite Co-ordinator before set-up, this year it will be GL-Events.

### INSURANCE

Exhibitors are urged to ensure adequate insurance cover is in place for all materials / equipment used.

The venue, organisers and sub-contractors may not be held liable for any damages or losses incurred.

### SECURITY AT THE VENUE

The venue has controlled access at all entrances. It is, however, recommended that no valuables are left at the stands.

### PARKING

There is ample parking at the venue. NO RESERVED parking will be available.

### BANKING FACILITIES

There are Bank ATM's within walking distance to the Venue.

### MEDICAL FACILITIES

A medic will be onsite for the duration of the conference.

### SMOKING

Smoking is not permitted within any closed area or within close proximity to the exit.

### WI-FI

Wi-Fi is available FREE of charge. Password can be obtained at the onsite IMESA Information Desk or the IMESA Exhibition Stand.

### ACCOMMODATION

Accommodation is the responsibility of the exhibitor and is for their own account. This year accommodation is available at Hotels along the Durban beachfront.

### MANNING STAND

An online link will be sent out to all confirmed Exhibitors to register the individuals that will be manning their stand. Link will be sent out in September 2026.

### REGISTRATION

Exhibitors are requested to register at the Conference venue in the Exhibition Hall at the IMESA stand on Tuesday, 27 October 2026, between 11h00-16h00.

### NAME BADGE

Your name badge will allow you access to the Conference Venue. Please ensure that you wear it at all times. Should you lose or forget your name badge proof of identification will be required before a new name badge can be issued to you at a cost of **R250**.

### EXHIBITION HALL

All meals and refreshments will be served in the Exhibition Hall for the duration of the conference.

### SOCIAL EVENTS

The Opening Function on Tuesday and Social Evening on Thursday are not to be missed this year. Full details are available on our conference website. 
The EXHIBITOR agrees to be bound by these Terms and Conditions with respect to support for the 2026 IMESA Conference & Exhibition and further agrees that it shall be bound by the rates, submission deadlines, cancellation deadlines, and cancellation conditions outlined below.

**COVID – any prepaid exhibition fees will be refunded should the government restrict conferencing, due to a covid outbreak.**

1. All participation is subject to the approval of IMESA who also reserves the right to decline or cancel expos due to non-performance.
2. No responsibility will be accepted by IMESA for loss arising from non-adherence to deadlines of whatsoever nature which, once provided to the Exhibitor, immediately come into effect and form part of this contract.
3. IMESA will use its best endeavors to deliver on its obligations to the Exhibitor correctly but will not be liable for any loss of profits or damages suffered by the participant as a result of the participant's failure to do so and any failure in this regard will not entitle the advertiser to withhold payment of the account rendered in any respect.
4. IMESA shall be exempt from any liability arising from force majeure or where performance of its obligations is prevented by circumstances outside its control.
5. Any complaints need to be received by **27<sup>th</sup> November 2026**. Complaints received after this date will not be entertained.
6. Should full payment for the EARLY BIRD PACKAGE not be received on / before 31<sup>st</sup> May 2026, IMESA will re-issue the invoice for the higher fee.
7. All amounts payable are due simultaneously by the date mentioned on this document as "payment date", save where IMESA has approved, in writing, an extension of payment deadline in which event IMESA reserves the right to suspend services if payment is not received on due date.
8. Verbal cancellation will NOT be valid: only a written cancellation via an email, with an acknowledged response from IMESA, will be accepted by IMESA and will serve as notice. Any cancellations made BEFORE 31 July 2026 will be subject to a cancellation fee which is 50% of the full invoiced price. Cancellations made AFTER 31 July 2026, will be required to pay 100% of the full invoiced price.
9. Should IMESA agree in its sole discretion to assist, or complete, requirements of the participant, then all IMESA's production costs will be for the account of the participant at standard industry rates.
10. Name changes will be at a cost of **R250 per name change** requested.
11. Nothing herein contained shall be interpreted as obliging IMESA to afford the participant any indulgence to effect payment after due date.
12. In the event of IMESA instructing its attorneys to collect any amounts, all legal fees and collection charges, determined as the maximum permitted fees and charges in terms of the NCA and its regulations, a commission of 20% (twenty percent) of the amount outstanding, and legal fees as between attorney and participant, shall be borne by the participant.
13. The Exhibitor agrees that these Terms and Conditions constitute a valid contract with IMESA and certifies that all information given herein by him/her/it to the representative of IMESA is true and correct.
14. This agreement is governed by South African Law and is subject to the jurisdiction of the South African courts. IMESA is allowed to institute legal proceedings for the recovery of any amount owing hereunder in the Magistrate's Court of any district which by virtue of Section 28 of the Magistrate's Court Act has jurisdiction over the advertiser, but this does not preclude IMESA at its own discretion from instituting legal proceedings in the Supreme Court of South Africa which has jurisdiction over the participant.
15. All terms and conditions relating to the services are set out herein. All other terms and conditions are excluded unless agreed to in writing by IMESA, and no other conditions, warranties or representations, whether oral or written, express or implied by statute or otherwise, shall apply hereto.
16. No concession, latitude or indulgence allowed by IMESA to the participant shall be construed as a waiver or abandonment of any of IMESA'S rights hereunder.
17. In the event that any of the terms of these Terms and Conditions are found to be invalid, unlawful or unenforceable, such terms will be severable from the remaining terms, which will continue to be valid and enforceable.
